The status on the camel clips will be given at the next meeting. No one has applied for the CWF trip.

New business: Clubs signed the civil rights assurance statements. State leader dues are \$3.00 each and need to be paid. The registered volunteer fees are \$10 each. The list of names was reviewed. Dues will be \$51 and Volunteer fees will be \$190. The Central Electric district supper will be January 2nd. Come at 5pm to set up with supper at 6:30pm. The 4-H auction will be January 25, 2020. Shifts will go as follows: Storla Stockers, Aurora County Siders, Country Kids, Bits & Bridles, Stickney Eagles. They will be 2 hr increments starting at 8:30am. Prices for the meals were changed to the following: BBQ \$2.50, Chili BBQ \$2.00, Hot dog \$1.50, Soup \$2, Pie \$1.50, Bar/Cookie \$.50, pop/water \$1.00, coffee \$.50, and meal deals \$7 and \$6.

There is a 4-H Teen leadership academy starting. Audra has more info. Sue informed us on some things. They would like 10 kids from Aurora Co. from grades 7-12 to be involved. We have a Land O'Lakes foundation/matching grant from Agtegra for \$283.64 that needs to be used for educational purposes. We just need to provide an invoice/receipt in order to get funds. Cheryl made a motion with Jill seconding it to apply it towards the Teen leadership. The SD 4-H leaders ass'n mini grant per county has been increased from \$200 to \$400. Counties can combine. Audra is applying for a combined county grant.

The 2019-20 Youth Development community service project is Teens for Jeans. Collect jeans and deliver them to identified local organizations. They can't be given for resale. There might be a drop box at the White Lake school. Each club is responsible for their totals. The Capitol day will be January 15th and is open to all 4-H youth. RSVP to Audra by December 15th. Start planning for the horse show. It will probably be in Sanborn. YQCA training dates will be December 27th at 1pm in Wessington Springs, January 20th in Plankinton, and Feb 17th in Springs.

Achievement days for 2020 will be July 30 and Aug. 1. Jerauld is Aug 3-4 and Sanborn is Aug. 6-8. Jill made a motion to approve the date and possible date for 2021 for Aug. 5 and 7. Kama seconded the motion. Cheryl and Tina will sort thru chairs in early December and surplus the bad ones for the 4-H auction. We will plan on keeping 300-350 chairs. Would the leaders approve more chair carts? Wait to see what we need.
