The Central Electric supper will be held on Monday, May 23th. Todd made a motion to serve it again with same menu as last year. We would have Kelvin cook the pork, get buns, big bags of chips, and salad from Ron's Market, and have a list for families to donate cookies. Elaine seconded the motion which passed unanimously.
